### **Quick Overview:**

- Limited to 16 Teams
- 4 Events + Finals
- Top 12 advance to finals
- 12 Pre-Lim Matches, 3 per event, all on the same day
- Prizes:
  - 1<sup>st</sup>: \$1000 Cash + 100 cases for 2013 Season + Free Entry to WIPS
  - 2<sup>nd</sup>: \$500 Cash + 50 Cases for 2013 Season + Free Entry to WIPS
- One Time Franchise Deposit: \$1000 due November 1<sup>st</sup>, 2011.
- Player Fee: \$250 per player x 12 players. Fee's to be paid in monthly installments of \$500 starting Dec 1<sup>st</sup> until all have been paid.
- Custom Jerseys for each team
- 2 Players from each team to be nominated for 2012 All Star Game



## **Detailed League Information:**

### **Format:**

Teams will play the current PSP RaceTo-7 Format having 12 pre-lim matches, playing 3 per event with the top 12 teams overall advancing to finals.

### **Dates:**

To be announced. Season will run from May – September having 1 event per month running both Saturday and Sunday. Teams will get all 3 matches in 1 day.

### **Jerseys:**

NAPL will include 12 jersey at no additional cost, to all 2012 teams. These jerseys may be completely custom to your team but must follow NAPL specifications to released at a later date. Teams are responsible to their own jersey design.

### **Media:**

NAPL will maintain its current website and content along with supply photo and video coverage at events where available.

### **Reffing:**

NAPL will supply a reffing staff at each event.

### **Prizes:**

1<sup>st</sup>: \$1000 Cash + 100 cases for 2013 Season.

2<sup>nd</sup>: \$500 Cash + 50 Cases for 2013 Season

### **All Star Game:**

Teams will nominate 2 players to play in the NAPL All Star Game to be held mid season.

### **Rules:**

PSP 2011/2012 Rule Book. RaceTo-7 Rule Set. NAPL addendums to be announced.

### **Paint:**

NAPL and its paint suppliers will make available 3 grades of paint at \$39.95 / \$44.95 / \$49.95

### **Location:**

All Events will be held at newly turf'ed event complex at Action Sports Park in Syracuse, NY. Syracuse, NY is located within 6 hours of most Major North East Cities.

### **Hotel:**

The 2012 Official Hotel of the NYPL will be the Holiday Inn Express which features 87 rooms, indoor pool, jacuzzi, fitness center, business center and best of all it is located on site, adjacent to HeadRush Action Sports Park.

**Restaurant:**

The 2012 Official Restaurant of the NYPL will be the Quaker Steak and Lube featuring 3 large dining area, 2 bars, outside patio, the best food ever and best of all it is located on site, adjacent to HeadRush Action Sports Park.

**Finals:**

The top 12 teams after pre-lims will be invited to finals where teams will be split into 4 brackets of 3, where the winner of each bracket will advance to Semi Finals 1v4, 2v3.

**Franchise Fee:**

NAPL will feature 16 franchised teams. A franchise may be purchased for a one time deposit of \$1000. This will grant you ownership of a team in NAPL. Deposits will be returned upon transfer of ownership or after a team completes a full season decides to not return.

Deposits are due November 1<sup>st</sup>, 2011.

**Player Fee:**

A player fee of \$250 will be due to complete in the NAPL. Player Fee's to be paid in monthly installments of \$500 starting Dec 1<sup>st</sup> until all 12 have been paid. A player will receive the following:

2. Custom Jersey
3. ID card
4. Lanyard
5. NAPL T-Shirt
